day of September, 2025.

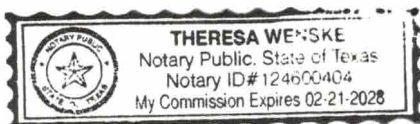

Detail Map

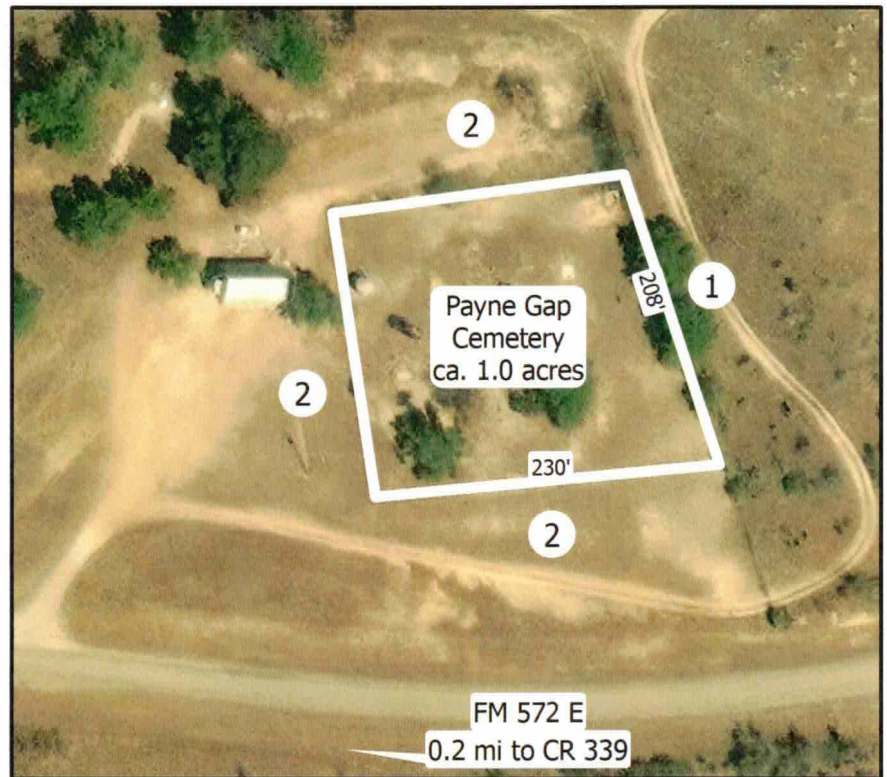
